Aug 24 1 Apologies

Aug 24 2 Declaration of Cllrs interests

Mr Bevans declared that he had received a gift of bottles of beer and chocolates from Halam School to thank him for helping them move and set up the stage in the Hall, when the School was unavailable. The PC could see no problem in this.

Mr Subramanian declared that he had not been charged for the use of the Hall as it was a charity event he was organising, the PC again had no problem with this and was happy for this to continue

Mr Bevans as booking secretary for the Hall will let the RFO have a letter stating the Hall was not charged for – proposed Mr Wright seconded Mrs Denyer – 2 for 1 abstension

The minutes were signed as a true and correct record after adding Mr Wright to the present list

The RFO handed a list of acceptable and not acceptable reasons for absence from a Parish Council meeting, to those who were not present at the previous meeting, reasons will not be minuted, name just listed and noted if acceptable

Aug 24 4 to adjourn to allow public participation

1 member of the public present, he came just to apologise for not being at the meeting when his planning was discussed

Cllr Rainbow added that his application may not go to committee, just passed by the planner

Cllrs Rainbow and Harris informed us that a lot of plans are not being referred to committee, they are going on the planning officers recommendation

Aug 24 5 reports for District and County Councillors

Nothing from Cllr Harris

Cllr Rainbow asked about the glass bins and if everyone had now received them as she had had one request in the Village from someone who had not. Discussion found that one resident prescent had a spare so they would sort it out

Mr Wright asked if there were any changes to the planning report, it seems there has been a relaxation on ground solar energy

Mayor funds have not filtered this far yet but some to Newark and Ollerton town councils
