APPENDIX TO THE AGREEMENT FOR USE of OSMINGTON PARISH FIELD

The field, including the fenced play area with equipment for children's use, is the property of Osmington Parish Council and is deemed for use by the local community/parish.

While the Parish Council is pleased for people to contract the field for use in conjunction with the hire of the Village Hall, the following conditions must be adhered to, in order to preserve it for its main purpose without additional cost to local ratepayers.

1. The parish field and, in particular, the children's play area, must remain accessible at all times to members of the public.
2. There is no parking permitted anywhere on the field, except for service vehicles.
3. You must ensure that you clear away any litter left by you or your guests and that you leave the Parish Field in a safe state for use by members of the public. Failure to do so may result in the retention of your deposit.
4. Any audio speakers used outside to transmit amplified music or speech must be angled to face away from houses on any side.
All amplified sound must be turned off by 9:30 pm.
5. Everyone must leave the field by midnight along with all their personal belongings. Noise after 11:00 pm should be kept to the minimum.
6. All marquees or other types of equipment must be located away from the children's play area and be removed within 48 hours of the end of the hire period, weather permitting. Any variation to this removal time would need to be negotiated at the time with the Parish Clerk.
7. No bonfires, fireworks or Chinese lanterns are permitted.
8. A refundable deposit of £100.00 shall be made payable to Osmington Parish Council no later than two weeks in advance of the contracted period of use. This amount or a proportion thereof may be forfeit if the field is not left in a clean and safe state or if any other aspect of the contracted agreement has not been satisfied.
9. The Parish Clerk will have delegated authority to consider an application to hire the Parish Field that was received with less than the minimum of a month's advance notice where this notice period was not possible.
10. Standard Exclusion Clause: "The council accepts no responsibility for any injury to the contracted user or any other person, or loss or damage to the property of the contracted user or any other person arising by virtue of their use of the Parish Field."
