(a). All Councillors with the exception of Councillor W. Boundary have received strong complaints from Parishioners regarding this site for which, Mr & Mrs Roberts have applied for permission for one caravan. It has been noticed that already, there are 2 caravans/mobile homes a shed and a Septic Tank. Apart from the breach of Planning Regulations it is causing a nuisance from noise (a generator) and vehicle parked on the road close to an intersection. It was also felt that the vehicular access itself would, if granted, be hazardous. The Clerk was instructed to write to Mid Devon District Planning Department and say the Council opposed this sporadic development in the strongest possible language.
