## Work to the Pavilion. Our Client: DB Works Limited

We have been instructed by DB Works Limited of Cherry Way Farm, Ewell Minnis, Dover, Kent CT15 7EA in connection with our client's claim against you for payment of the sum of £8,965.20 being the balance due under an invoice rendered on 31st May 2023.

On 6th December 2022 our client provided a quotation to Mr Morgan the then Chairman of the Northbourne Parish Council for work to be carried out to the Pavilion. The quotation was in three parts being work to the roof for £6,467.00 plus VAT, the fitting of new windows and doors for £6,989.00 plus VAT and to clean shrubs and weeds and lay down a membrane for the sum of £732 plus VAT.

On 27th January 2023 the quotation for work to the roof and the groundwork was accepted by the Clerk to the Council in an email addressed to our client and copied to Mr Morgan. Subsequently Mr Morgan gave an oral instruction to our client to also proceed with the works to the windows and doors. The work was referred to in emails from our client to the Clerk and Mr Morgan dated 4th and 9th May 2023. Both emails were acknowledged by the Clerk with the acknowledgment being sent to Mr Morgan. The work was subsequently completed. We are instructed that no issues were raised with our client by the Council notwithstanding the emails that had been sent and the fact that it would have been obvious that the work being carried out included the replacement of windows and doors.

On 31st May 2023 our client raised an invoice for all works carried out. We are instructed that part payment has been made but that the balance has been challenged on the basis that no record could be found of approval of the installation of the windows. Our client's position is that he relied upon the instruction of the then Chairman of the Council and that the emails support his contention that the instruction was given. There remains a balance outstanding of £8,965.20.





We are instructed that the Council has indicated that it does not have sufficient funds to settle the balance now due. Our client would therefore be prepared to resolve this matter upon the basis that you make an immediate payment of £3,000 and that the balance is settled on 1<sup>st</sup> April 2024. Please confirm these terms can be agreed. In the event that they are not agreed we shall advise our client upon the issue of proceedings.
