As previously agreed, the precept will be increased to £20000 for the municipal year 2024/5. The demand issued by Dover District Council was therefore signed by Cllr Edelman as Chair and the Clerk.

d. to discuss obtaining a .gov domain for this council.

Cllr Edelman has previously mentioned the benefits which might be obtained by obtaining a .gov domain name for the parish council. The Clerk has researched how the application can be made and identified a company which would provide the service. From the domain names available it was agreed that **northbourneparishcouncil.gov.uk** is the best option. Costs:

.gov.uk domain - £110 + VAT every 2 years Email hosting - £49.99 + VAT per year.

It was decided that Cllr Pays would look into this from a professional IT angle, to be discussed at the next meeting.
