- **1. Election of Chair** S Baker proposed J Elliott, seconded by D Holmes and J Elliott was duly elected as Chair. A Declaration of Acceptance of Office of Chair was signed in the presence of the Clerk.
- **2. Election of Vice Chair** D Holmes proposed S Baker, seconded by A Sellick and S Baker duly elected as Vice Chair.

- **4. Declarations of Interest** D Holmes Item 7d personal interest as event being organised by a relative.
- **5. Minutes of the Previous Meeting** It was unanimously agreed that the minutes of the meeting held on the 29th of February 2024 are a true and correct record and were signed by the Chairman at the meeting.

7. Matters Outstanding

- a. **SALC Wellbeing Grant Application** Clerk informed that the money available would be covered by the power granted by S137 and therefore limited. Cllr Mowat will liaise further and develop a plan with costs for the project for a recorded social history project.
- **b. Grass Cutting** Cllr Mowat undertaking the main areas of the green, although currently No Mow May is occurring. The Triangle had been cut.
- c. Emergency Planning following the March Exmoor LCN it was suggested that parishes register a community place of safety. It was thought that the Village Hall was the obvious choice. The Chair of the Village Hall was in attendance and will take the suggestion to their next meeting for consideration. A request was made to SC Cllr Pugsley for Emergency Planning workshops to be facilitated through the Exmoor LCN to help develop a plan.
- d. D-Day Commemoration A representative from the Village Hall informed that there is to be a lamb roast, children's games and music provided by a ukulele group. 70 tickets had already been sold for the first weekend in June. Tickets are £13.50. It was proposed by S Baker and seconded by C Mowat for the parish council to support the event to the sum of £250 which was unanimously approved. Cllr Holmes had declared an interest and not involved in the discussion or resolution.
- **e. War Memorial** it was suggested that the Clerk obtain quotes to clean and restore the lettering on the memorial.
