#### 061/23 To receive and accept apologies.

#### 063/23 To accept the Minutes from the last Parish Council meeting.

#### 065/23 Matters arising

- a. the Old Vol noise complaints the meeting discussed the information provided by the owner on how he had taken action to stop the DJ sets and other louder events. The meeting agreed we would have to see if that too effect as it was aware that prior to that the noise level was high and impacting villagers. It would be considered again at the next meeting

#### 076/23 To receive update on St Aidan's Church

(This item was discussed after item 062/23).

Andrew and Joanne have formed a Working Group with Geoff Firmin (ex-officio) and now have permission from the Parochial Parish Council ("PCC") to apply for grant aid. They have approached Notts Historic Churches Trust ("NHCT") who have visited St Aiden's and see no reason why they wouldn't grant aid, but they can only do so up to a maximum of £4,000 (although four applications can be made in a year). In addition, a NCHT officer looks to fill gaps in funding through other grant applications. They will ask for extra funding from St Mary's, but are not hopeful for much as no funds. In addition, they will ask villagers for any funding. They need initially about £25,000 in total to repair externally (roof and windows).

The PC asked how they would answer the question from villagers as to why contribute if church continue to fail to maintain and will they contribute to repair what church should have done. The Working Group said they would pick that up.

On the church use there is a paper from the church to Bishops Council in September. Dioscesean policy is that for clarity and certainty the Parish Church has the regular Sunday service (St Mary's and St Helen's) with the other four churches once a month on Tuesday continuing. There is an average of 12 in the congregation at St Aiden's.

The group have drafted a letter to villagers asking for indications only and have sent that to the PCC for approval. They hope to issue it in September with comments back in October so they can approach NHCT in November to start repair works in the Spring. Ideally with St Aiden's day 30 August they could have a special service to celebrate.

## 077/23 Correspondence received.

Emails were received: one regarding boy racers and requesting an update on Hoveringham Road and Brackenhill Junction being fixed. One from NSDC Environmental Health and Licencing Officer regarding a solicitors letter received on behalf of The Old Vol and noise nuisance.
