The term 'relevant person' therefore means you and any other person referred to above.

- 4. The requirement to notify the Monitoring Officer of any non-pecuniary interests or gifts and hospitality which the Code requires you to register applies only to your own interests and not those of your spouse or civil partner.
- 5. Details of your notified interests will appear in the Members' register of interests and will be published on the Council's website, and open to public inspection.
- 6. If you consider that the disclosure of the details of any of your interests could lead to you, or a person connected with you, being subject to violence or intimidation, and you would like to withhold these details from the register of interests, please provide this information to the Monitoring Officer and explain your concerns regarding the disclosure of the sensitive information, including why it is likely to create such a risk. If the Monitoring Officer agrees, the information will not be included in copies of the register made available for inspection, or any published version of the register.
