#### 5. PLANNING MATTERS

Councillor Daly reported on the following planning application:-

# (i) Planning Consultation Reference: 24/00417/FUL

Location: Betley Court Main Road Betley

Proposal: Removal of condition 3 of planning permission 21/01064/FUL to allow the continued use of the visitor hub for classes, meetings and small gatherings in addition to its use in association with the permitted opening of gardens as a visitor attraction. (18/00943/FUL)

Councillor Daly added that no objections had been received to date from residents and it was noted that the applicant had made provisions to alleviate any parking problems.

# (ii) Land at Doddlespool, Betley. Reference 17/00186/207C2

The Clerk reported that she had received notification from Newcastle-under-Lyme Borough Council on an update on the progress of the works being undertaken at this site following the planning application for the retention and completion of a partially constructed agricultural track, approved under planning permission 21/00286/FUL.

The report stated that the latest information, was as previously reported, that works to the track were largely complete and the landowner now needed to carry out the approved landscaping works. Officers were progressing the appropriate enforcement action against the

landowner to ensure that the landscaping works were completed, as required by condition 4 of planning permission 21/00286/FUL,

### (iii) Local Register Review
